SANITATION SUPERVISOR INVOLVED IN MVA WITH PRIVATE MOTORIST, INJURES BACK WITH SURGERY - GETS \$250,000

Sanitation Supervisor on routine patrol in Brooklyn hit by 72 y/o driver insured by Allstate. He sustained severe low back injury and never returned to work. We were successful in obtaining the full insurance policy of \$250,000 prior to jury selection.

SANITATION WORKER SLIPS AND FALLS IN BX6 DUE TO ICE, LOST 5 MONTHS AND GETS \$90,000!

Sanitation Worker, Annalee Feliciano, slipped and fell in Bx6 due to ice build up from a broken overhead sprinkler pipe. She had a wrist surgery and returned back to work after 5 months. We were successful in obtaining a settlement of \$90,000 or \$18k for each month she lost from work.

SANITATION WORKER GETS 3/4 ACCIDENT DISABILITY PENSION FOR MVA WHILE DOING A RELAY

Sanitation Worker, Barbara Gager, was doing a relay on the west side highway when she was cut off by a private motorist causing an accident. She sustained soft-tissue low back

injuries and never returned to work. We were successful in helping her obtain her 3/4 accident disability pension.

SANITATION WORKER GETS 3/4 ACCIDENT DISABILITY PENSION AFTER BEING STRUCK BY TIRE CHAINS

Sanitation Worker, Michael Colon, was in a Manhattan Salt Pit watching a co-worker try and dislodge a collection truck from the salt pile when the tire chains suddenly broke and struck him in the back. He sustained a severe low back injury, never returned to work and was about to be medically separated. Our office was able to intervene and get Michael his 3/4 accident disability pension.

FILE A NOTICE OF CLAIM WITHIN 90 DAYS OF YOUR ACCIDENT WITH THE NYC COMPTROLLER
